



## **ASA ONLINE JOURNAL SERVICE INDIVIDUAL USER AGREEMENT**

**1. THIS AGREEMENT** between the member identified below (“Member” or “you”) and the Acoustical Society of America (“ASA”) grants you the right to access the online version of The Journal of the Acoustical Society of America for which you maintain, through membership in the ASA, a current subscription to the printed or CD ROM version thereof, subject to the terms and conditions set forth in this Agreement.

ASA reserves the right to change the terms of this Agreement upon thirty (30) days’ prior written notice, which may be by e-mail, fax or other communication.

### **2. User Identification and Password**

After this Agreement is signed and returned to ASA, a message will be sent to the e-mail address you supplied in Section 1. This message will direct you to ASA’s online publishing office, the American Institute of Physics Online Journal Service Registration Center, where you will be able to select a User ID and Password of your own choosing.

# TERMS and CONDITIONS

## 3. Authorized User

**ASA's grant to you of online access to JASA, for which you maintain, through membership in ASA, a current subscription to the print or CD ROM version thereof extends only to you individually and may not be transferred to, or extended to, others.**

You agree to maintain your User ID and password as private and confidential information. Unauthorized use of the Member's User ID and password for online access to JASA, with or without the Member's knowledge, is a breach of this Agreement and a violation of ASA's copyrights.

## 4. Permitted Use

The Member is permitted online access to JASA, and may download or print text, search results, or other information from JASA solely for the private use or research of the individual Member. The Member agrees to use this online access in a way that conforms with all applicable laws and regulations. The Member specifically agrees not to make any attempt to gain unauthorized access to any other system or network.

ASA grants the Member permission for brief quotations from JASA article texts, with the customary acknowledgment of the source, subject to the restrictions, if any, set forth in the article.

## 5. Prohibitions on Certain Uses

Altering, recompiling, copying, reselling, redistributing, publishing or republishing (beyond the brief quotations permitted under Section 4) of any journal text, output, search results, or other information from JASA, or any portion thereof, including without limitation, copyright, trade secret, proprietary and/or other legal notices contained therein, in any form or medium is prohibited. Systematic downloading, service bureau redistribution services and/or the making of print or electronic copies for transmission to non-members and/or non-subscribers are prohibited. All rights not expressly granted are reserved to ASA.

ASA shall not be required to distribute, and Member shall not redistribute, the JASA online journal to a country where the export thereof is prohibited by U.S. law or regulation.

## 6. Duration of Agreement

This Agreement will become effective on receipt by ASA of the Agreement signed by you, and, subject to the terms and conditions of this Agreement, will remain in effect while you maintain a current print subscription to JASA through your membership in ASA. This Agreement will terminate:

- a. Subject to (b) and (c) below, if your subscription through membership to the JASA print or CD ROM journal lapses (termination is effective at the end of the period during which a membership subscription is maintained).
- b. Immediately, if any term or condition of this Agreement is violated for any reason, knowingly or unknowingly.
- c. Following thirty (30) days' prior written notice by ASA of any change in the terms of this Agreement, receipt by ASA of notice from you in writing, or by e-mail or by fax that you do not accept such change or changes. (In the absence of any such objection by Member, ASA's new terms shall apply.)

## 7. Copyright

The JASA online journal and its contents including abstracts, are copyrighted by ASA and are subject to all applicable copyright,

database protection and other rights of ASA as copyright owner and publisher under the laws of the United States and other countries. Copyright notices in JASA may not be removed, obscured, or modified in any way.

## 8. Failure of Performance

Following online access approval, the Member will be permitted to attempt online access to JASA at any time. ASA, however, will not be liable for any delay, downtime, transmission error, software or equipment incompatibilities, force majeure or other failure of performance. ASA will use commercially reasonable efforts to correct any material performance problem brought to its attention and may suspend performance pending such correction.

## 9. Official Version of Record

ASA is responsible for ensuring that the online version of JASA corresponds in content with the print version, but ASA does not guarantee that it does. In the event of any inaccuracy or any discrepancy between the print and online versions, the print version will be the official version of record.

## 10. Disclaimer of Warranties; Limitation of Liability; Indemnification

ASA warrants that it is entitled to grant the licenses granted in this Agreement. EXCEPT AS SET FORTH IN THE PRECEDING SENTENCE, ASA MAKES NO WARRANTY OR REPRESENTATION OF ANY KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE JASA ONLINE JOURNAL, INCLUDING ITS QUALITY, ORIGINALITY, SUITABILITY, SEARCHABILITY, OPERATION, PERFORMANCE, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

ASA SHALL NOT BE LIABLE FOR: EXEMPLARY, SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR OTHER DAMAGES, ARISING OUT OF OR IN CONNECTION WITH THE SUBSCRIPTION OR LICENSES GRANTED HEREUNDER, THE USE OR INABILITY TO USE THE JASA ONLINE JOURNAL, ASA'S PERFORMANCE UNDER THIS AGREEMENT, TERMINATION OF THIS AGREEMENT BY ASA OR THE LOSS OF DATA, BUSINESS OR GOODWILL, EVEN IF ASA IS ADVISED OR AWARE OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL THE TOTAL AGGREGATE LIABILITY OF ASA FOR ANY CLAIMS, LOSSES OR DAMAGES ARISING OUT OF ANY BREACH OR TERMINATION OF THIS AGREEMENT EXCEED THE TOTAL AMOUNT PAID BY THE MEMBER TO ASA FOR THE ONLINE JOURNAL SUBSCRIPTION, BUT NOT LESS THAN TWENTY-FIVE DOLLARS (\$25.00), FOR THE CURRENT SUBSCRIPTION YEAR IN WHICH SUCH CLAIM, LOSS OR DAMAGE OCCURRED, WHETHER IN CONTRACT, TORT, OR OTHERWISE, INCLUDING WITHOUT LIMITATION DUE TO NEGLIGENCE.

The foregoing limitation of liability and exclusion of certain damages shall apply regardless of the success or effectiveness of other remedies. No claim may be made against ASA unless suit is filed thereon within one (1) year after the event giving rise to the claim.

The Member assumes sole responsibility for all use of the JASA online journal and agrees to indemnify and hold ASA harmless from and against any and all claims, liabilities, damages, expenses (including attorneys' fees and experts' costs, penalties and fees, if any for the enforcement of this Agreement and otherwise for ASA's defense of indemnified claims), losses and threatened losses arising from or in connection with any breach of this Agreement, including without limitation, claims of unauthorized use.

**11. General**

This Agreement constitutes the entire agreement between the parties and supersedes any prior communication between the parties with respect to the subject matter hereof. Subject to termination under Section 6, this Agreement may be amended only by a written instrument signed by both parties. The headings used in this Agreement are for convenience only and are not to be considered in construing the terms of this Agreement.

The Member may not assign or transfer his/her rights under this Agreement. The provisions of Sections 4, 5, 7, 9, 10 and 11 hereof shall survive any expiration or termination of this Agreement.

This Agreement will be governed by, and construed in accordance with, the laws of the State of New York, applicable to contracts entered into and fully performed in the State of New York. Any action arising out of or relating to this Agreement or JASA shall be brought in courts situated in Nassau County, New York and the parties consent to the jurisdiction of such courts.
