## ROSSING PRIZE IN ACOUSTICS EDUCATION

**Nomination deadline: 1 April 2019**

The Acoustical Society of America (ASA) announces the availability of a prize to honor an individual who has made significant contributions toward furthering acoustics education, through distinguished teaching, creation of educational materials, textbook writing, and other activities.

**Eligibility:** An individual must be nominated by a colleague or a present or former student. The nominee need not be a member of the Acoustical Society of America.

**Award:** The 2019 award consists of a medal, a certificate, a \$4,000 stipend, and reimbursement of travel expenses up to \$1,000 to attend the fall 2019 ASA meeting in San Diego, CA, where the award will be presented.

**Evaluation and Selection Process:** Nominations will be reviewed and evaluated by a subcommittee of the ASA Committee on Education in Acoustics.

**Nomination Procedure:** Nominations require completion of a one-page form, a current curriculum vitae, a nominating letter, and two (or more) seconding letters. At least one letter must be from a Fellow of the Society. The CV should include, in addition to a list of publications, a summary of other relevant educational materials, such as books and videos, to be considered by the subcommittee.

All materials should be sent to the address indicated below. Letters must be on letterhead and include the signatures of the nominators or seconders. Submissions by e-mail attachment must be submitted no later than 1 April 2019. Material sent by postal mail must have a postmark no later than 1 April 2019. The individual who is selected will be notified by 31 May 2019.

**Expectations of Prize Winner:** The award will be presented at the Plenary Session at the fall 2019 ASA meeting in San Diego, CA. At this meeting the recipient will be expected to deliver the "Acoustics Education Prize Lecture" in a session sponsored by the Committee on Education in Acoustics
